#### 2021 AT-A-GLANCE

#### **JANUARY**

We announce our 2021 free webinar series, Beyond the Basics. The series concluded in October and reached over 1,900 participants throughout the year.

#### **APRIL**

With StopHazing, we release a new free resource, the Campus Commitment to Hazing Prevention: Action Guide, highlighting how campuses can commit to hazing prevention.

#### **SEPTEMBER**

We launch our first ever National Campus Safety Awareness Summit, bringing together almost 1,000 campus safety professionals for two days of virtual and free education.

#### **FEBRUARY**

Clery Center presents at several national conferences throughout the year, including the National Association of Student Personnel Administrators, the National Organization for Victim Advocates, and the Network for Victim Recovery of DC.

#### JUNE

With the International
Association of Campus Law
Enforcement Administrators and
the Anti-Defamation League,
we create a new free resource
for public safety officials on how
to recognize and prevent hate
crimes on college campuses.

#### **OCTOBER**

We partner with ADT to create a campus safety survey, the findings of which result in a set of campus safety tips for students and their loved ones (see survey results on page 6).

#### NATIONAL ADVOCACY LEADERSHIP TRAINING

Clery Center partnered with the National Organization for Victim Assistance as a subject matter expert for their National Advocacy Leadership Training (NCAT). NCAT is an advanced training academy that builds skills in responding to sexual



assault, stalking and interpersonal violence in higher education. Campus and community-based victim advocates from across the country participated to learn more about a range of topics including trauma-informed advocacy, Boundaries and Confidentiality in Campus Advocacy, and the Clery Act requirements.

#### HAZING PREVENTION LEGISLATION

2022 marks 15 years since Clery Center board members and advocates Gary & Julie DeVercelly lost their son, Gary, Jr., to hazing. They have worked tirelessly to get anti-hazing legislation passed and we continue to be hopeful for the passage of the REACH Act (read more on page 8). Tragically, he succumbed to a heart attack on January 1, 2021. PGCC leaned heavily on its Clery Center Membership to elevate its program during a very challenging time.

### Personal safety is top of mind on college campuses across America

#### Student safety concerns & takeaways


This school year, many college students are reporting that they are concerned about their personal safety on campus. ADT and Clery Center partnered to uncover students' top safety concerns as well as resources they are tapping to try to stay safe.

When freshmen are on campus for the first time, there is an increased risk of sexual assault called the Red Zone — but this semester, freshmen and many sophomores will fall into this category — creating a potential 'Double' Red Zone.

of college students are concerned about their personal safety as they return to campus

#### **POLICY UPDATE**

Since its founding in 1987, Clery Center has engaged with policymakers in recognition of the significant impact that could result from legislation: driving systemic change on college campuses. Building on this history and experience we developed a two-year policy agenda to inform and guide our advocacy priorities. The agenda outlines three key priorities:

- 1. Seek dependable guidance from enforcement authorities
- 2. Ensure equity for all survivors of dating and domestic violence, sexual assault, and stalking
- 3. Heighten awareness of pressing campus safety issues and their impact on under-resourced communities

#### 2021 Progress/Highlights

- Submitted written and public comment in response to new proposed Title IX regulations
- Strengthened relationship with survivor organizations including End Rape on Campus, It's On Us, and the Student Voice Coalition
- Provided expertise and feedback to legislators and ally organizations on various bills that aim to impact campus safety
- Partnered with StopHazing and Julie and Gary DeVercelly on the successful reintroduction of the Report and Educate About Hazing (REACH) Act [S. 744, H.R. 2525]
- Developed several resources and outreach tools to educate the community about the impact and importance of the REACH Act and secured endorsements on the bill from over 30 national organizations


