FROM THE EXECUTIVE DIRECTOR



Dear Supporters,

2022 marked 35 years since Howard and Connie Clery founded Clery Center, then Security On Campus. We honored this anniversary in the way that felt most fitting to our founders, by staying focused on the ever important work of making campuses safer. As institutions of higher education emerged from

a global pandemic, they faced perhaps even greater challenges of rising national crime rates, a historic number of mass shootings, and a growing mental health crisis among young people. Issues that permeate far beyond college campuses, but that schools are uniquely positioned to be both blamed for and equipped to prevent.

In responding to these complex challenges, the history of our organization is important because it tells the story of the evolution of campus safety and our role in guiding it. Clery Center wasn't initially seen as a partner to institutions of higher education; we instead played a necessary role in calling out schools for their lack of transparency and unwillingness to take responsibility for keeping the campus community safe. But over time, schools began to prioritize policies and programs to make campuses safer and, in many cases, became leaders for violence prevention and victim support. As institutions of higher education evolved, so did Clery Center, and we knew we could have the biggest impact as their partners.

Partnership and collaboration are now what drives our work. You all, our supporters, are evidence of that. You helped us far exceed our fundraising goal for National Campus Safety Awareness Month 2022 and to subsequently reach thousands of campus-based professionals with free and low-cost programs. You helped with our continued advocacy for federal anti-hazing legislation and the development of the new Campus Commitment to Hazing Prevention Action Guide. And we know we can count on you to continue to support Clery Center's mission in 2023 and beyond.

Tulane University hired its first dedicated Clery Act Coordinator in December 2021. Margaret E. Martin, Tulane's Clery Act Coordinator, utilized the university's Clery Center membership to guide the review of existing policy and the formation of new procedures. Additionally, Tulane hosted a two-day training with the Clery Center for university stakeholders to elevate institution-wide understanding of the importance and intersections of the Clery Act.

ANTI-HAZING ADVOCACY

2022 marked the fifteenth anniversary of Gary DeVercelly, Jr.'s death as the result of a fraternity hazing ritual. The DeVercellys are one of countless families whose children have been harmed because of hazing. Clery Center continues to advocate for federal legislation that seeks to prevent hazing in higher education.

In July of 2022, Clery Center, StopHazing, SAFE Campuses LLC, parents, and advocates met with members of Congress on both sides of the aisle to share personal stories of hazing and to highlight the urgent need for federal legislation. Among those who met with lawmakers were Clery Center board members Julie and Gary DeVercelly, Sr., parents of Gary, Jr.; Cindy Hipps, mother of Tucker who was killed in 2014, Kim and TJ Burch, parents of Nolan who was killed in 2014, Marie Andre, mother of George Desdunes who was killed in 2011, and Eric and Linda Oakes, parents of Adam who was killed in 2021.

"Hazing is a dangerous—and at times deadly—problem on college campuses, and we must work to end it," <u>said Senator Amy Klobuchar (D-MN)</u>. "This legislation will require colleges and universities to include hazing as part of their annual crime reports, giving us a comprehensive and accurate understanding of hazing so we can create effective measures to address it."




FINANCIALS
